St. Anne Catholic School Tuition Agreement/Tuition Payment Method

Tuition Charged vs. Actual Cost: The actual cost of tuition at St. Anne Catholic School is approximately \$4,975 per K-8 student. The difference between the actual cost of education and tuition charged is met by parish subsidies, fundraisers, gifts and contributions. *Families financially able to do so are encouraged to contribute the difference between the actual cost of tuition and the tuition amount charged.*

SCRIP Fee: All St. Anne School families are to generate a minimum of \$375 in SCRIP profit for St. Anne School for the 2012-2013 school year. Only SCRIP purchased between May 15, 2012-May 14, 2013 is credited to the SCRIP fee, and only parents and grandparents of St. Anne students may purchase SCRIP to be applied as credit toward the SCRIP fee. A designated SCRIP order form must be completed and submitted by the buyer when buying SCRIP to insure credit is applied toward this fee. A family may opt out of the SCRIP fee amount by paying the \$375 fee in full on or before October 1, 2012. A family not meeting the minimum SCRIP fee requirement is responsible for paying the SCRIP fee amount or any balance remaining on the SCRIP fee amount by May 31, 2013. Families exceeding the \$375 Scrip minimum will be given a 50% credit of amount over \$375 towards 2013-2014 tuition.

Fundraisers: The tuition rates for 2012-2013 do not reflect the money budgeted to be raised from school fundraisers. Fundraisers are part of the school's operating budget and keep tuition costs down.

Parish Cluster Support: The cluster parishes (St. Anne, Assumption, St. Joseph) financially support St. Anne Catholic School. Registered members of the cluster parishes are expected to financially support their parish. In terms of the "treasure" component of the stewardship obligation for Catholics in the cluster parishes, each school family registered in one of the three parishes in the cluster should contribute a minimum of one hour's wage per week to their cluster parish.

The FACTS fee for this service is NOT part of tuition or school registration fee. *FACTS enrollment/re-enrollment forms must be received by 6/10 for 10 payments to begin 8/10 or 11 payments to begin in July).*

Tuition Assistance: St. Anne Catholic School and the cluster parishes that support the school make considerable effort to provide a Catholic school education to families who chose to enroll their children in St. Anne Catholic School. The cluster parishes provide support in the form of subsidies to the school's operating budget and by donations to a tuition assistance fund. Families in need of tuition assistance should contact the school principal or parish life coordinator.

Non-payment: If payment cannot be made when due or as agreed, it is the responsibility of the family to contact St. Anne School to make other arrangements according to a written, signed payment plan. Option I or II amounts not paid when due result in forfeiture of tuition discount. Interest on any unpaid, past due amounts will accrue at the rate of 1% percent per month. Non-payment may affect the release of academic/grade reports. The costs of any necessary formal collection, including any agency fees/or and reasonable attorney fees, shall be added to tuition/fees due.
